(*) The difference between the values shown in the "min / max" columns is essentially a function of morphological and plant peculiarities and of the specific location in the reference areas of the relevant spaces

(**) At Palazzina MU in only one case the charge applied is higher and equal to 20.0 €/sqm/month: this is an agreement with Carboil, a company operating in the "into-plane" segment which required space - 246 sqm of changing rooms and offices - set up and customized by and at the expense of ADR; on the basis of the aforementioned expenses, the parties agreed on a rent higher than the range in the table (€ 17.77 - 18.26). In consideration of the specificity and uniqueness of the contractual relationship, this charge has not been included in the corresponding section

(***) In the section on Cargo City, the values relating to the agreements in place with Alha and X-press are not considered as they are both assigned through a public tender with an economic offer (as per material published in GURI and GUUE)
